CONTRACTUAL TERMS: It is understood and agreed that this is a Legally Binding Contract, and that:

1. **This is a monthly rental contract – NOT A RENT TO OWN.** Renter may return the instrument at any time & terminate this contract, provided all payments are current at date of return. **ALL INSTRUMENTS MUST BE RETURNED TO BRICKHOUSE MUSIC AT 216 S. MAIN STREET, RIVER FALLS.** The instrument will then be evaluated by our in-store instrument technicians and renter will be liable for any necessary repair.
2. _____ months of rental payments may be applied toward the purchase of an instrument, (12 mo for orchestra) however no refund of money will be made if the instrument is returned. Rental accrued will be applied prior to purchase discount.
3. Brickhouse Music will retain title of described merchandise until FULL payment has been made.
4. _____ **I/we agree to keep in my possession & not to sell, mortgage or dispose of this rental until it is paid in full.**
5. Renter's personal information included will NOT be released to outside parties, except in collection efforts, should Renter default on contractual terms. Collection will include full retail price of the instrument and all Collection fees assessed.
6. Brickhouse maintenance coverage is available and advised. Customer will be responsible for all adjustments and repair unless covered by Maintenance Program. (See below for Details).

Optional Maintenance Program - \$5 per Month

Brickhouse Music agrees to keep instrument in proper playing condition, and will offer 50% off on any chemical cleaning when under maintenance.

Program does NOT cover:

1. Replacement of items such as reeds, oils, cork grease, drumsticks, mouthpieces, excessive damage to cases, loss, theft, etc.
2. Any instrument other than that which is covered by this contract/program.
3. Reimbursement for repair services not obtained at Brickhouse Music.
4. Damage done by unskilled persons attempting repair.
5. Excessive or malicious damage or destruction done by renter. (Fees for large dents or hard-to-reach dents will be imposed).
6. Maintenance on Rental Instruments which are arrears in payment.

Maintenance Program Costs:

\$5 per month (Maintenance is included in trial period price)
Program must begin with the initial rental payment, & may be cancelled at any time. Program may not be implemented mid contract.
Highly recommended for trial period renters during a new student's "learning curve".
